Vendor Packet

I would like to invite you to participate in our 26th Annual SAKA Koi Show, to be held November 10, 11 & 12, 2006 with set-up on November 11, here in Tucson, Arizona. We normally get participation from around the country, and expect this year's show to be bigger and better than ever. Our Koi show will bring in approximately 200 fish from Arizona, Colorado, Oklahoma, New Mexico, Texas and California. We hold our Show and Vendor Fair at the **Kino Veterans Memorial Park 2805 Ajo Way Tucson**, across from Kino Hospital, where on an average day; over 1,000 people are in attendance. We are advertising in all local and county newspapers and radio and we hope to get a spot on TV. Posters will be placed at all garden centers, pet stores, feed stores.

The purpose of the Vendor Fair is to introduce club members as well as the community to new products, services & vendors in the fish/water garden industry.

We would like to offer you the opportunity to display and sell your goods at our 26th Annual Koi show. We have four different plans this year.

Plan A - Is a covered vendor booth and will consist of a 10' X 10', with one 8-foot table and 2 chairs. (\$200.00)

Plan B - Is a covered vendor booth and will consist of a 10' X 10', with one 8-foot table, 2 chairs & 2 tanks. (\$250.00)

Plan C - Is a vendor booth and will consist of a 10' X 10', with one 8-foot table and 2 chairs (\$100.00)

Plan D - A Non Profit booth, consist of a 10' X 10', with one 8-foot table and 2 chairs. Covered if available (N/C)

Additional Tanks (\$50.00 each)

Note that your booth is for 10X10 only no merchandise may be place anywhere other than in your booth

**** We will have electric and air supply for any fish vendors.

**** If payment and form are received after October 20, 2006 there will be an additional \$50 late fee.

The vendor area will be open to the public Friday 10th 4PM - 7 PM, Saturday 11th 9AM - 4PM and Sunday 13th 9AM - 4PM. Set-up is scheduled from Noon - 4:00 pm on November 10th.

We are limiting the number of vendors to 3 from each category - Fish, Plants, Novelty Items, Landscaping and Clubs.
